
## FY 2019 Public Records Highlights

#### Number of Requests Received and Closed in FY 2019

The University of Iowa received **724** public records requests for the fiscal year ending June 30, 2019, a slight decrease compared to last year, when 741 requests were received. The decrease can be attributed to the withdrawal of two ongoing requests processed throughout last year for the weekly data file of textbooks at the IMU (which accounted for 68 requests in FY 2018, but 0 requests in FY 2019).


706 requests were closed in FY 2019, including 29 requests that were still pending at the end of FY 2018. Requests completed with responsive documents totaled 567. 59 requests were withdrawn or deactivated due to lack of payment, and 34 requests were denied pursuant to confidentiality exemptions under lowa Code Chapter 22. For 46 requests, no responsive records could be found. 47 requests were still pending at the close of the fiscal year.

Overall, the number of public records requests received in one year has held fairly steady for the past few years, but **more than tripled** since FY 2010 due to large increases between FY 2014 and FY 2017.




#### **Response Times**

**76 percent** of requests were completed within 10 business days, and **88 percent** were completed within 20 business days.



#### **Requests Received by Category**


For the third year in a row, the top five most requested categories remained the same, with the category of **Public Safety** (which includes requests for police incident and accident reports) once again making up the largest share of public records requests, with 193 (27% of the total requests received). **Student Services** was the second most requested category, although the number of requests for records such as student directory lists and student data/statistics decreased by 21% compared to last year (from 156 to 123). **Athletics** (including coaches' contracts and athletics financial reports) was the third leading category, and requests related to **Purchasing** (such as bid proposals and vendor contracts) and **Human Resources** once again rounded out the top five most requested categories.

### **Affiliation of Requestors**

243 of the 724 requests received in FY 2019 (34%) came from the media: 183 from Iowa reporters (117 from the *Cedar Rapids Gazette* alone), and 60 from out-of-state reporters. 231 requests (32%) came from businesses/vendors (including bidders, insurance agencies, and companies requesting student directory information), a 12% decrease from last year's 262 requests. Other types of requestors included students and researchers from other colleges/universities (42 requests), attorneys (21), and labor unions (24, including a recurring request from SEIU, processed every three weeks). Private citizens, or individuals with unknown affiliation, accounted for 18% of the requests received (131).

#### **Types of Records Requested**

In FY 2019, the university received 178 requests for **police incident/accident reports**, making those reports the most requested type of record. Requests for **contracts** were the second most popular type of request. 73 vendor/supplier contracts were requested, followed by 39 requests for employment contracts (mainly for coaches and athletics department employees).

126 requests were made for **data/statistics** or lists generated from databases (not including **student directory** lists, which accounted for 67 requests received in FY 2019). Data was requested on a variety of topics, including purchasing (e.g. purchase orders, lists of outstanding checks), healthcare, HR/salary data, and student services. 82 requests involved gathering **emails or other types of correspondence** from UI employees.

63 out of 724 requests received in FY 2019 involved multiple types of records. For instance, numerous requestors asked for vendors' contracts as well as bid tabulations or all proposals submitted for an RFP.

Although well-short of the 23 requests received last year, the **most requested document was once again Kirk Ferentz's employment contract as head football coach**, with 13 requests. The university received nearly as many requests (12) for the contracts of the football offensive and defensive coordinators. The FY 2018 NCAA Financial Report was the most requested non-contract (12 requests, along with 6 requests for past years' reports).
